- III. Director's Report
 Director Vlasuk gave an update on the department.

Directors Report September 2023

- Increased social media presence
- Reminder, The Health Department did receive the maximum State allotment of COVID test kits. Test kits are available both at the entrance to City Hall and at the Health Department office located in the lower level of City Hall. Director Vlasuk encourages everyone to come take as many as they wish. If the state begins to distribute COVID test to homes. The Health Department will post this information on their Health page.
- Completed Summer 2023 camp inspections
- Completed State camp reporting
- Health department conducted a food drive in the month of August and delivered all items to local food pantry
- Blood Pressure Clinic was held in the City Hall Auditorium September 12, 2023 from 10am to 2pm. 46 people attended
- Additional Blood Pressure Clinics are held the second Tuesday of every month at the Senior Center from 11am to 1pm
- September 21, 2023 the Health Department will be offering Flu, Shingrix, RSV and COVID, vaccines from 11 to 2 at the Council on Aging
- Blood Drive will be held Wednesday November 29, 2023 from 12-5pm at the Senior Center

- First Kennel inspection conduced at 473 Merrimac Street
- The Northeast Massachusetts Mosquito Control and Wetlands Management District conducted helicopter applications of the biological larvicide, VectoBac12AS (EPA reg. 73049-38) to control mosquito larvae over salt marshes in Salisbury, Newburyport, Newbury, Rowley, and Ipswich on August 2, 2023 and August 30, 2023 covering 60 acres each time.
- Water testing has ceased for beach 2023 season and will resume in May of 2023.
 Conversation evolved and Mrs. Matta discussed that she had received calls from a
 resident that was doing his own research. Dr. Tilson advised the Board that he is working
 on a grant regarding CSO. Mrs. Matta will have the individual contact Dr. Tilson directly to
 discuss.
