The sand will be stockpiled in the parking lot and trucked to the nourishment area along the frontal dune and in the depressed area at the back of the dune. The project includes fencing, plantings and signage. The expected completion date is December 16.

#### **CZM Grant**

The contract for the new grant has just been received. It was delayed because CZM wished to revise the scope. It should still be possible to complete the project by the June deadline.

#### The Merrimack Valley Beach Alliance Meeting

The meeting that was held on November 4 focused on the studies the Army Corp has undertaken in neighboring communities, not Newburyport. The topic of discussion at the next meeting, which is scheduled for December 9, will be emergency preparedness.

Notice of Intent

Mara Robinson represented the applicant and described the plans to improve the site. A deck with stairs and a ramp would be added to create a seating area near the shed. A raised wood planter would be constructed adjacent to the house to screen the utilities. A sculptural element would be added adjacent to the stairs to screen the view under the house. An outdoor shower was shown on the plan but was not included in the narrative.

A DEP file number has not yet been received. The NOI must be revised because the amount of impact to the coastal dune was not included on the form. The Commission members requested the dimensions of the planting box be added to the plan. They wish to receive cross sections of the deck and the planting box showing the lowest horizontal structural members would be at least two feet above grade. A notation must be included indicating the volume of gravel to be removed from the site and the amount of sand being brought in. The proposed location of the curb cut must be shown.

Steve Moore moved to continue the public hearing to the December 6 meeting. Dan Warchol seconded the motion. The motion was unanimously approved.

Dan Warchol moved to close the public hearings. Steve Moore seconded the motion. The motion was unanimously approved.
