1. Call to Order

Newburyport Wetlands Protection Regulations

The Commission members discussed proposed amendments to Sections 2, 3, 5 and 6 of the regulations. In Section 2 a definition of critical area would be added. In Section 3 language would be added to provide protection for projects that are outside of the buffer zone but would affect critical jurisdictional resource areas. Language would be added to Section 5 about Orders of Conditions. Julia Godtfredsen will revise the proposed amendment to Section 6, which pertains to lattice and other enclosures, based on the comments made at the meeting and will circulate it to the members for review.

Julia Godtfredsen will contact CZM about the way in which the presence of reindeer moss on a site should be handled. Reindeer moss is a lichen and not a plant material but is of value to the dune system because it holds sand in place.
