May 6, 2014 City Council Chambers Minutes

1. Call to Order

A meeting of the Newburyport Conservation Commission was called to order by Chair Joe Teixeira at 6:45 p.m.

2. Roll Call

In attendance were members Joe Teixeira, Steve Moore, Paul Healy, Jim O'Brien, Dan Warchol and Doug Muir.

3. Minutes

Steve Moore moved to approve of the minutes of the April 15, 2014 meeting as submitted. Doug Muir seconded the motion. The motion was unanimously approved.

4. General Business

Massachusetts Department of Conservation and Recreation

Maudslay State Park

Informal Presentation

Alexandria Echandi said a stone bridge at Maudslay State Park has been closed due to erosion. Visitors to the park who fail to use the appropriate trail to access the bridge have caused the erosion. DCR wishes to install a series of terraces made of stone and lumber and plant the area with native vegetation to block the short cut. The work would take place on the bank and in the buffer zone of an intermittent stream. The work would be done by hand and natural materials would be used. Because the project would not result in a long-term impact to resource area, would promote public safety and would prevent further erosion, the applicant will be allowed to file an RDA instead of a Notice of Intent. The submittal of before and after photographs will be a condition of the RDA. A vista management program will also be included in the filing. The item will be on the agenda for the June 3 meeting.

5. Certificates of Compliance, Requests for Determinations, Requests for Minor Modifications

Michael Seekamp said a list of items to be completed was made during the site visit. A rutted area near the pump station has subsequently been loamed and seeded and the plastic erosion fencing has been removed. The concrete blocks located in the rain garden at lot 14 have been removed. One item of particular concern was the substitution of infiltration chambers for rain gardens. Christiansen and Sergi submitted a letter confirming the system would have the capacity to infiltrate the roof runoff during a 100-year storm event. Tadpoles were found in two spillways that were retaining water. The water level will be lowered after they have become frogs. Amended plans were submitted that show silt would be removed and additional riprap placed to

slow the water where erosion has occurred in the swale that runs toward the mitigation area. The homeowner at lot 14 removed a mature pine. The Commission members discussed how information might be provided to homeowners about prohibited activities on properties located adjacent to wetlands. The distribution of a brochure Seekamp Environmental Consulting developed for the Haverhill Conservation Commission to educate homeowners about rain gardens might be possible.

The list of outstanding items includes the removal of the "no trespassing" signs, the reduction of the water level in the spillway and the repair of the area where erosion has occurred. The work will begin around June 1 and the Commission will be notified when it has been completed. Paul Healy moved that a Certificate of Compliance be issued upon the completion of the work. Steve Moore seconded the motion. The motion was unanimously approved.

The trees are very small and there is a concern about their survival. The remainder of the work has been completed.
