1. Call to Order

Chair Joe Teixeira called a meeting of the Newburyport Conservation Commission to order at 6:50 p.m.

2. Roll Call

3. Minutes

Steve Moore moved to approve of the minutes of the June 17, 2014 meeting as amended. Dan Warchol seconded the motion. The motion was unanimously approved.

4. Old and New Business

Plum Island Updates

- The Army Corp has completed the work on the south jetty and has the funds to begin work on the north jetty.
- In 2016 Salisbury, Newburyport and Newbury are expected to receive approximately 340,000 cubic yards of sand from the dredging of the Piscataqua River. Funding is needed to cover the cost of transporting the sand from the Isle of Shoals to Plum Island. The three towns will be responsible for the permitting of the placement of the sand. The sand would be deposited off shore, as it would not be suitable for the beach.

Master Plan Update

A survey will be sent to city residents with questions relating to all of the categories to be covered in the updated master plan. The subcommittees will continue to meet over the summer and public meetings on the draft document will be held in the fall.

The applicant wishes to add a second door to a small structure. The existing deck would be extended to the location of the new door. No existing vegetation would be impacted by the extension of the deck. The applicant wishes to install the deck on sonotubes. DEP does not approve of the use of sonotubes but the reason behind this is not clear. Julia Godtfredsen will contact DEP for clarification on the issue. The Commission members did not deem it necessary to delay permitting for an addition to a deck while waiting for this clarification. Dan Warchol moved to issue a Negative 2 Determination with the condition that no dune grass adjacent to the new deck and stairs shall be removed either during or after construction. Steve Moore seconded the motion. The motion was unanimously approved.
