## **Ballot Question #3**

Lucas Phipps discussed Ballot Question three, which is a referendum on the 2016 Gender Identity public protection law (MA 2047): guarantees equality for transgender individuals regarding restrooms, stores, public places, locker rooms.

Referendum was initiated by **Keep MA Safe**. They were able to get enough signatures to put repeal of the transgender bill on the Ballot

Main donor in support of repealing the law is MA Family Institute. They are clearly against Marriage equality.

If you want to **Keep the Current Law / Protections in place** Need to vote YES on question 3. The wording is confusing. Even though the Ballot question is about repealing the current law, a vote of yes keeps the current law and transgender protections. A no vote repeals the current law and transgender protections.

Massachusetts is known as progressive and welcoming. Also the city of Newburyport known as this. Would like to see a resounding win here as well as statewide.

Ballotopedia has objective information about the bill. They present both sides of the arguments and points for and against. Encourage all to review this site.

Freedom MA is running the opposition campaign.

They have a Mayors coalition – Lukas has sent HRC an email encouraging Mayor Holaday to sign on.
