#### 2) Inquiry on One Day License

Inquiry for an event in a local park, picnic style where people could bring their own wine. Would be 40 to 50 people. Not selling wine, just bringing their own. Not a non-profit organization.

The commission would want TIPs certified servers and a way to ensure that no under-age drinkers would be served. Commissioners stated if this were on private property it would not be an issue. Recommended to make a detailed proposal with more advanced notice.

# 4. Hearing - New All Alcohol License

The hearing was opened at 7:15pm by Commissioner Sharp. Robert Ciampitti, attorney for EMNIC, Inc., is requesting a new all alcohol license for 24 Winter St., the former Joseph's Winter Street Café. Tom Bean and James Rogers are the principals and both are native to Newburyport. They both have long term restaurant experience. The restaurant will continue to be on the first floor only with 128 proposed seats. Minor changes to configurations but no structural changes other than appliances. Working with building,

plumbing and electrical inspectors for the City to have everything to code. The bar area will have high top tables, no piano.

Questions: Staffing: expect to hire 25 to 30 with approximately 20 full times.

Valet: full valet service

Menu: Italian, fresh food, locally sourced, creative with fun bar menu.

Hours: Monday to Saturday 4 to 10pm, Sunday noon to 9pm. Entertainment: Acoustical music on Thursday and Friday nights.

#### **Public Comment in favor:**

Rick Durbin, 18 Winter St., direct abutter, glad to see something fresh coming in. Wants to be sure valet parking does not use the condo lot. Wondered about exterior renovations.

Rob Ciampitti stated that there is a planned traffic flow for the valets and they will not be using the condo lot. Also, the landlord is responsible for the exterior, they are doing interior.
