4. Hearing – Alteration of Premises – Newburyport Brewing Company, 4 New Pasture Road

Bill Fisher, co-owner of the Newburyport Brewing Co. attended the meeting. He introduced their tasting room manager, Deanna Moreau. He is asking for approval for a "pop up park" in a 20 x 40 space outdoors with seating for 32 (thirty-two) at 8 (eight) tables, accessible only through the tasting room. He stated that they would like to offer their patrons an opportunity to sit outside during the nice weather to enjoy their beer. The area will be cordoned off with barrels and two white ropes between the barrels. For emergency exit purposes, there will be two sections with a yellow chain link attached with a clip. There will be signage at the emergency exits that state clearly that no alcohol is allowed beyond this point. Patrons will have to purchase the beer inside. They can also purchase food from Metzy's Taqueria truck which has an order table inside the doors of the tasting room. All alcohol will remain in the tasting room or the patio area. The commission stated their concern that this is an industrial park.

No one spoke in favor of or against this application.

5. Miscellaneous

- 1. John Brown of the Spirit of Newburyport Transient Vendor cart appeared regarding the use of the canopy at his cart. The commission noted that after the visit to his cart on July 8, 2015, Mr. Brown did remove the canopy. During Yankee Homecoming he did use the canopy and took it down immediately following the festival. He used the canopy as all of the vendors during that week have canopies/tents. He apologized for stepping outside of the Ordinance and acknowledged that if he had read the Ordinance completely none of this would have ever occurred. The commission requested that he maintain his cart within the specifications of the Ordinance. No further action taken.
- 2. Commissioner Devlin will bring the updated policies and procedures to the Sept. 2, 2015 meeting for review and further discussion. At that point it is anticipated that the draft will be shared with a few stakeholders for feedback and then a public hearing on the new policies and procedures will be held in November.
- 3. The fee schedule will be reviewed at the September meeting.
