New Business

Inn Street restaurant seating

Property owners of restaurant at the former West Row Café building presented a revised proposal for outdoor seating on the Inn Street park space including removal of the pergola allowing all amenities to be moveable. Liquor commission approved it with a rope or chain that designates where alcohol can be served. Two items need further exploration:

- 1. Commissioners asked that Director Reid coordinate a conference call with former Commissioner Ann Lagasse to assist with defining an annual fee;
- 2. ask Attorney to review a draft license agreement based on the old one and revisit "exclusive use" laws.

Motion to approve pending resolution of issues listed above by Commissioner Ellsworth, seconded by Commissioner Griffin. So voted on a unanimous voice vote.

Wells at Cashman Park
