Call to order: 6:02 p.m.

A quorum was present

In attendance: Ted Boretti, Matthew Ellsworth, Paul Swindlehurst, Kimberly Turner

MEETING MINUTES

Motion to take agenda items out of order by Commissioner Swindlehurst, seconded by Commissioner Ellsworth. So voted on roll call vote, 5 yes.

OLD BUSINESS

Use of Rail Trail to access 30 Winter Street

Commissioner Turner gave a summary of the history of the item, i.e. the commission had approved a license in October to allow developer Eric Primack to use the Clipper City Rail Trail to bring a dumpster to his property. In November the commission revoked his license because he cut down a tree on public property and other equipment had been brought to the site without permission.

Commissioners reviewed draft license agreement drafted by the mayor's office, Parks Department and City Solicitor, which expanded the scope of work from the original agreement, required the contractor to post signage letting the public know when work would be performed, put time limitations on when work could be done and allowed for the Parks Commission to determine a required deposit against damages.

Motion to sign the agreement that was distributed to the commission to review and that called for a cash deposit of twenty thousand dollars by Commissioner Swindlehurst, seconded by Commissioner Griffin. So voted on roll call vote, 5 yes.

Basketball-pickleball courts at Lower Atkinson Common

Commissioners listened to comments for and against renovation and striping for multi-purpose use of the athletic court at Lower Atkinson Common. Commissioner Turner clarified that tonight's vote is only for the renovation of the multi-use court for pickup use only until a later time when scheduling of organized use can be discussed and that she does not want to prevent any user from being able to use the parks.

Motion to take the park surface that's in discussion and that's in bad repair and authorize work to proceed to secure funds and design to get the surface fixed and not to remove it from the collection of amenities at Lower Atkinson by Commissioner Griffin, seconded by Commissioner Ellsworth with the caveat that engineering for the drainage is tied directly with this.

Motion to amend previous motion to resurface the court and make it into a multi-purpose court by Commissioner Griffin, seconded by Commissioner Ellsworth with the previously stated caveat related to drainage. So voted on roll call vote, 5 yes.

Nu Kitchen Outdoor Seating at Patrick Tracy Square (Katie Taricani-Hickey, Joshua Van Dyke)

Nu Kitchen presented a proposal to repair bricks at Patrick Tracey Square and add amenities including outdoor seating, umbrellas, temporary pergolas and temporary fire pits to be used as outdoor dining when they are open and also welcoming and used by general public at any time.

Commissioners expressed concerns about traffic flow through the park, perhaps addressed by just using one side, making sure applicant understands there are ongoing permitting fees, making sure the space is clearly open to the public especially when restaurant is not open, about the precedent that pergolas were denied on Inn Street previously, concerns from residents of the Mercantile building being against this use, displacing park users, permanent or semi-permanent retail installations in our parks, amount of space being taken up, alternative to use on-street "parklet" space and limiting access to public especially in downtown spaces. The applicant withdrew his application.

Outdoor Dining at Brown Square (Wellington Augusto, Kim Turner)

Commissioner Turner presented her draft plan for re-design of Brown Square (attached).

Welling Augusto asked for permission to use Brown Square for outdoor dining during the same hours the restaurant was allowed last year. The commission asked for resolution about the following two issues before they would move on this item:

- whether the applicant needs City Council approval to serve alcohol in the park because he has to cross a public street to get to the park; and
- how much City Council will be charging per seat for restaurants that use on-street parklet space for outdoor dining.

The item was continued until a future meeting. The commission listened to public comment including a concern about conflicts with the veterans' memorial area large size of dining area and asked Director Reid to followup with the Veterans Administrator to get feedback.

Review of CPC Grants

Director Reid summarized the three projects the commission-department are applying to CPC for funding including Frog Pond Cleanup, Joppa Walkway Replacement and Lower Atkinson Common Improvements.

Motion to adjourn by Commissioner Griffin, seconded by Commissioner Boretti. So voted on a unanimous voice vote.
