Planning and Development (B: pg. 182, C: 19)

- **AK** Not enough staff, regular concern. Not a lot of change in past couple of years. Want to hear from you as Dept. Head. AP 2 positions would be helpful zoning/permitting would be helpful, Other area that could need help can only take a few major projects at a time so proj. management would be helpful.
- **AK** as we look at this dept, need to be aware of work we are creating. Short term rentals, creating a burden in FTE setup
- **CP –** Same question. Have you asked for more staffing. AP Have had discussions but doing best we can.
