Cnclr Wallace..talked about the process. Center Line in middle, 11ft travel lanes, 5ft shoulders. Not narrowing street, Pioneer area is more complex. Plan goes down to Forrester St. Looking for a commitment from Administration to ensure area is safer, ie more crosswalks.

JEWhite...center line in middle, shoulder varies but mostly +/- 5ft. At PL travel lanes are 10.5. Hash marks block out parking to create the area of a sidewalk. CW...missing a crosswalk at Moulton.

Q: Cnclr BVogel...design and expense of handicap ramps?

JEWhite: the 45 degree angle allows us to keep trees just trim to 6ft, and get shoulder to 5ft ecact.

Q; Cnclr Tontar...how many spaces are lost? A: with on street about 10-12
Cnclr Lane..who'll be trimming trees? And when? We need to move on this.

Subject: Stripping plan for Merrimac St.

The current proposed plan for stripping Merrimac St. was released April 30th and discussed at a Public Safety Meeting May 3rd. In this discussion it was stated that parking along Merrimac St. would be eliminated.

The plan will eliminate parking along the length of Merrimac that has been resurfaced by adding a (up to) 5' shoulder line on both sides of the street. This is the type of stripping that was proposed for High Street many years ago, with the shoulder being a bike lane. This was hotly debated and revamped.

Residents of Merrimac St. are unaware of these changes being made. It was the recommendation of the Public Safety Committee that the current plan will be submitted to the City Council for approval. I think residents need to be aware this is happening and insist on public input and hearings to this effect.

All agree that we need Merrimac Street relined as soon as possible, but to make changes like this is not being representative of the people you serve.
