Minutes:

Attorney Mark Reich (KP Law): Summarized firm's capabilities, availability, and free trainings.

Mayor Holaday: Happy to reappoint KP Law. Very few disappointments over 8+ years.

Cllr. Khan: How might cllrs. converse directly with KP Law? Reich: That is up to the City.

Cllr. Devlin: Who is your client?

Reich: City of Newburyport, not Mayor or any one Cllr. How the City communicates with its solicitor is up that the City. Suggests that individual cllrs. go through Council President to control costs and avoid "weaponizing" City Solicitor.

Khan: Should City officials seek a second opinion to KP Law's opinion on a matter? Should the City Council have its own line item for legal services? Found legal advice during marijuana

debates of 2018-2019 "sloppy," and turned to Attorney General in absence of KP Law advice. *Reich*: Not customary for his firm's clients to seek second opinions. Opinions given are to the "City," not Mayor or City Council per se. Was available through City Clerk Jones to answer all marijuana-related inquiries from councilors; disagrees with characterization of sloppiness.

Cllr. Zeid: Nothing more important than an engagement letter. Information must be shared with Council regarding all matters, including personnel. Requests timely updates. What happens when the Council and the Mayor disagree on a legal point?

Reich: Opines for the City. Favoritism of Mayor vs. Council could mean losing the client. *Pres. Eigerman*: Charter includes a declaratory relief remedy for that situation.

Zeid: KP Law should note more aggressive role that City Council has taken in litigation. City Council was never informed about existence or status of lawsuit brought by former high school student against City in connection with alleged, off-campus rape.

Reich: Last year's municipal code amendments on this point are noted. KP Law not involved in litigation cited by Cllr. Zeid.

Holaday: Would have been happy to debrief City Council in executive session if she had been asked. Personnel issues will remain confidential with the Mayors Office.

Cllr. Tontar: Please include citations in your opinions. Reich: Will when appropriate.

Eigerman: Plan is to have Cllrs. consult with the City Solicitor through me, for the reasons suggested by Attorney Reich. Please copy me on updates to the Mayor. Let's "put a pin" in the issue of "personnel": not clear what is entitled to remain confidential with Mayor in that area. Last year, did specifically ask for information about litigation referred to firms other than KP Law, including the litigation referenced by Cllr. Zeid. City Solicitor's ethical duties of "loyalty," "confidentiality," competence," and "information" extend to the City Council.

Devlin: How common is it for KP Law partners/associates to sit in on board of commission meetings?

Reich: Rare. Sits himself at Watertown City Council, but for other bodies, KP law attends, perhaps, twice or three times a year, only, for complex matters.
