Newburyport Conservation Commission

October 18, 2011 City Council Chambers Minutes

1. Call to Order

A meeting of the Newburyport Conservation Commission was called to order by Chairman Joe Teixeira at 6:30 p.m.

2. Roll Call

In attendance were members Joe Teixeira, Steve Moore, Dan Warchol, Paul Healy and Doug Muir and Planning Director Andy Port.

3. Minutes

Paul Healy moved to approve the minutes of the October 4, 2011 meeting as submitted. Steve Moore seconded the motion. The motion was unanimously approved.

4. General Business

Virginia Lane Swale Restoration

Steve Moore recused himself from the discussion. Some members of the Commission visited the site. Andy Port said the City plans to file a Notice of Intent for the work. Fabric would be placed in the channel of the swale to prevent vegetation from growing but the fabric would not prevent the infiltration of water. Joe Teixeira said there is an intermittent stream in the area that shows on USGS maps. It is a major feeder of the Little River and the water flows down stream to the industrial park. He said that while he understands the City's need to address the issue, there are regulations that must be followed and the presence of an intermittent stream might impact the ability of the work to be done. Andy Port said he does not think the intermittent stream would be a deciding factor. Paul Healy said work had previously been allowed in the area and he does not think the presence of an intermittent stream would make a difference in this case. Dan Warchol said the water should be slowed down as much as possible. Andy Port said there are several steps that must take place: the residents must sign an agreement to allow the work to be done, the City Council must approve of the funding and the Conservation Commission must approve of the work.

55th Street Beach Access Walkover

Andy Port said he drafted an agreement for the gangway and he is waiting for comments from the Harbormaster. The Harbormaster would be responsible for notifying the DPS and Planning Department when a storm is expected in order that the gangway might be lifted. Tony Funari must sign the agreement and two abutters will be asked to sign it as well.
