1. Call to Order

A meeting of the Newburyport Conservation Commission was called to order by Chair Joe Teixeira at 6:30 p.m.

2. Roll Call

Plum Island Updates

Joe Teixeira said he received a communication from Tim Tracy saying the coir bags at 53rd Street were becoming damaged. People have been walking over the bags to get to the beach because the ramp is closed. The City installed fencing and signage.

Julia Godtfredsen said Dr. Hemani would like the beach in front of his property to be scraped, as was done in Newbury. She does not think the location would meet the State's criteria for scraping because the beach is shorter and there is not enough sand. She advised him to refortify his sandbags.

Julia Godtfredsen said the scope of work for the jetty has been increase because more funds are available than originally thought.
