#### 223 Low Street

**Informal Discussion** 

The property owners wish to reduce the size of the rain garden. They said it does not function as it should, making the driveway icy and unsafe in the winter. The location of the rain garden also makes it difficult for cars to maneuver around it. The work could be done as an amendment to the Order of Conditions because a Certificate of Compliance has not yet been issued. The Commission members will review the file at the next meeting.

#### **Coltin Drive Foot Path**

**Informal Discussion** 

Larry Guinta described plans to revitalize a footpath that runs on City land between Pheasant Run Drive and Coltin Drive. The improved path would allow students to safely reach Low Street without walking along Hale Street. The path would not be paved and would be in the same location as the existing one, but the DPS would be asked to level and widen it. The Commission members would allow an RDA to be filed for the work. The wetland line must be added to the plan to allow them to determine if the path is in the 25-foot no-disturb zone and the way in which the regulations would impact the project. They wish to receive information on the trees that would be impacted and more detail on any grading that would be done.

Paul Healy moved to issue an Order of Conditions with the perpetual condition there shall be no snow storage in the no-disturb zone and the special conditions that prior to the start of work the 25-foot no-disturb zone between flags A14 and A31 shall be marked in the field and the applicant shall submit for review and approval 1) a plan for permanently marking the area between flag A14 and the western property line to prevent disturbance of the wetland during the maintenance of the stormwater feature, 2) a plan to prevent vehicular traffic from accessing the rain garden and the no-disturb zone and 3) a revised erosion control plan showing the extension of the erosion control around the outfalls of the rain garden and the pocket wetland. Steve Moore seconded the motion. The motion was unanimously approved.
