1. Call to Order

Chair Joe Teixeira called a meeting of the Newburyport Conservation Commission to order at 6:50 p.m.

3. Minutes

4. Old and New Business

Plum Island Updates

- Some beach access conflicts created by the new berm along Reservation Terrace have been resolved.
- The next meeting of the MRBA is scheduled for July 13.
- The City has received a municipal vulnerability preparedness grant to study the protection of the water treatment facility.
- Newburyport, Salisbury and Newbury joined together to hire GZA to prepare the permits for the off-shore placement of the sand that is to be dredged from the Piscataqua River. GZA has completed the permitting. The dredging itself has not yet been funded.

Whittier Bridge

Julia Godtfredsen and Steve Moore met under the Whittier Bridge with the contractor to evaluate the location of the required salt marsh mitigation plantings. The existing salt marsh vegetation in the area is not thriving. The Commission members approved a plan for an alternative mitigation area. No vote was required.
