End of Public comment

Councilor Donahue states the 60% AMI should be changed to "60% or less" to match the underlying zoning.

Councillor Vogel motions to amend the communication from 60% more than to 60% or less than AMI". Councilor Lane is the second. Committee votes 3-0 to update communication language to state 60% or less than AMI".

Cllr. Cameron speak in support of the RFI. It addresses preserving the gym as a community space and it will get us information that will help focus an RFP. Requests the language of the communication being "request for information" be updated to Expression of Interest.

Cllr. Lane states Cllr. Cameron is spot on and recommends recommending this to the full council.

Cllr. Shand lets Cllr. Zeid speak before moving forward with Cllr. Lane's motion.

Councilor Zeid speaks to not approving of the process and will not support anything that keeps the gym as part of the RFI.

Councillors vote 3-0 in favor of updating communication language to match the underlying effort or the order to be "expression of interest"

Councilor Vogel motions to approve ORDR 428 as amended to include the language from the amended COMM464. Councillor Lane seconds. Committee votes 3-0 to bring ORDR428 as amended to the full council and 3-0 to receive and file COMM464.
