## **Newburyport Historical Commission**

City Hall Conference Room April 2, 2015 Minutes

### 1. Call to Order

Chair Linda Smiley called a regular meeting of the Newburyport Historical Commission to order at 7:30 p.m.

### **Beacon Avenue Real Estate Trust**

9 Beacon Avenue

Full Building Demolition

Lisa Mead represented the applicant, George Haseltine, who wishes to demolish a Victorian house and replace it with a slightly larger structure. Attorney Mead said the house is sided with vinyl and the windows are vinyl as well. She said the house is not in good condition and is not listed on the inventory. She added there are several houses of a similar style, some more elaborate, on nearby Lincoln Street. Linda Smiley pointed out that not every structure that could be deemed to be historically significant was included on the inventory. Certain structures were chosen for the list to represent a style.

Mark Bilodeau said the style of the house is that of a historic home. The historical significance of a structure would not be diminished by the presence of vinyl siding and vinyl replacement windows. He said the house could be made attractive by the addition of proper windows and the removal of the vinyl siding. Sarah White pointed out a site visit usually takes place when a full building demolition is proposed. Malcolm Carnwath said he would like to see the house.

Linda Smiley opened the meeting to public comment. Tom Kolterjahn said the structure appears to be a solid one and he would like it to be preserved. The house is not structurally deficient and it is within the National Register District. He said a house should not be demolished and replaced with a new structure simply because it is small and modest.

Linda Smiley moved the structure is historically significant. Mark Bilodeau seconded the motion. A roll call vote was taken: Linda Smiley, yes; Stephen Dodge, no; Margaret Welch, yes; Malcolm Carnwath, yes; Mark Bilodeau, yes; Sarah White, yes. The motion was approved.

A site visit will take place on Saturday, April 4 at 9:00 a.m. A public hearing will be scheduled for the April 16 meeting.
