1. Call to Order

Acting Chair Stephen Dodge called a regular meeting of the Newburyport Historical Commission to order at 7:30 p.m.

Modification of Preservation Restriction

DCOD Advisory Review

Lisa Mead represented the applicant and said that since 2010 the NHC has held a preservation restriction on the structure. The applicant is requesting to modify this preservation restriction in order to construct a 134-square foot addition at the rear of the structure. The second-story addition would house a bathroom and closet. It would not alter the footprint or extend above the roofline of the main house.

Ned McGrath moved to notify the Planning Board and Zoning Board that the Historical Commission approves of the modification of the preservation restriction according to the plans as presented. Christopher Fay seconded the motion. The motion was unanimously approved.

DOD Advisory Review

Patrick Heffernan represented the applicant, who is proposing to remove a 104 square-foot sunporch from an 1840 Greek Revival structure. In addition, a door would be removed from the sunporch area and a slider would be added near the rear of the structure. Three windows would be moved and replaced with three windows in a different configuration. The existing windows and siding are of vinyl and vinyl replacement windows would be installed. The applicant's representative argued the work involves the alteration of exterior features that are not historic and would not detract from the integrity of the form of the structure. The Commission members suggested that more period-appropriate window treatments could be installed that then might be augmented by future property owners. They concluded the applicant should be allowed to proceed with the plans as presented because the structure has been heavily modified and the changes would not impact the view from the street.
