1. Amendment-Change or Alteration of Premise Information

- a. Port Tavern – Port Tavern has filled out all the necessary paperwork for the State for an Alteration of Premises adding outdoor dining, remaining the same as last year. The seating capacity for both inside and outside will total 146. Talk regarding the number of Occupancy of 220 was mentioned since the city has granted them this amount years ago. Craig Holt has spoken with the City of Newburyport's Building Commissioner Greg Earls and he concurred in fact the number is correct. We will submit their application to the ABCC and if there is a push back we will share what we have learned from the building department.
