# 14. Informational inquiry

John Bertone inquired as to whether food trucks need to get a transient vendor license or how they are licensed. This would be parked on the street or in parking lots. It is a restaurant on wheels.

The commission discussed that the Health Dept. would need to approve for serving food. Questions that arose are is there a process for permitting this type of vendor, does it change on private or public property and who has the authority to issue a license.

#### 15. Informational inquiry

The commission was asked f the city would consider a distillery for vodka. Main purpose would be to make and sell over the bar. The commission said there would be two pieces the distillery and the distribution/bar. The commission noted that bars must also serve food, there are no establishments that serve alcohol only. Questions arose as to the odor from a distillery. There is a sweet, grainy smell. Could also consider wholesale manufacturing and distribution instead of selling over the counter in a bar/restaurant.
