**Roll Call**

**2. Change of Manager**

- a. Tuscan Kitchen Newburyport, 38 Rear Merrimac Street

Corey Heagarty appeared as the new manager for Tuscan Kitchen. He has been with them since 2019. He has managed restaurants in Portsmouth and Portland.

She wants to get the business back open through Covid. Stephanie is the owner and Haven will be the general manager. Stephanie is also a dispatcher with the Georgetown Police department and a part time dispatcher in Newburyport. She will leave the full time position to be at the business, expecting 40 to 60 hours per week. They plan to open from 4pm to 12am Sunday through Thursday and 11am to 12am Thursday through Saturday. They are retaining one other employee. They will not have wait service and the floor plan is the same.

He opened a restaurant with Beer & Wine in 2008 in Worcester that he ran and managed and opened another in 2016 in Somerville with full alcohol. It will be fast, casual and healthy food. They plan to be open 7:30am to 10pm Sunday to Saturday, serving alcohol from 8am and from 10am on Sundays. It is not a bar feel but a healthy, upbeat place. They will stress local and organic food.
