### **Public Comment:**

- Gary Tedillio, 13 Coffin Street, lot was approved in 2014 with no issues
- Carol Meinhardt, 27 1/2 Jefferson Street, 33 year resident. Stated fire department didn't
  have any safety concerns with her property relative to the nearest fire hydrant. The road is a
  private way
- Meria Svirsky, 4 Coffin Street, Resident since 1984, family there since 2002. No safe sidewalks on Merrimac Street. Pathway through Coffin to Jefferson is more appropriate than trying to walk on Merrimac Street. Keep it as a pathway.
- Candy Mitchell, 29 Jefferson Street, Private way, burden of proof resides with people stating it's is not a private way.
- Jane Snow, 9 Coffin Street, Commented on the communication written regarding amount of frontage required at 13 Coffin Street
- Jeffry Trail, 27 Jefferson Street, Coffin Street is a private way and the burden of proof otherwise is on the person stating otherwise.
- Lynn Barone, 6 Coffin Street, The pathway through to Jefferson is the safe and legal way to walk across the Jefferson
- Stephanie Niketic, 93 High Street, confusing for a long time, need to right the wrong
- Deanna Eastman, 9B Coffin Street, safety concerns with getting vehicles turned around on her property.

Councillor Eigerman stated in prior terms, the recommendation to do a title examination was made but not executed.

Chapter 90 doesn't take credit for the streets the city took credit for. Confusion from prior decisions is evident.

Recommends writing an order for the city council to have the city solicitor complete a title examination of the property.

Committee agrees 3-0 to work on an order to present to the city council with above direction.
