It was also agreed that the action that Andy Port would take the modified spreadsheet of the adaptation strategies and convert to a Word document, assign dept/position responsibilities, eliminate redundant columns and data, remove redundant recommendations provide a numbering system and keep consistent with the Resiliency Plan report would be carried out after the release of the Resiliency Plan.
