This is an older communication. City already bans city-use of glyphosate, the ask was for CC to pass a measure to ban use by private citizens. CC cannot ban private use as against MA GL.

### **COMM 243 5-11-20 Ltr from J Rascal wrt NMMCD**

Ltr writer wanted this committee to recommend that City not fund NMMCD program and seek out alternatives. Membership in NMMCD is under the purview of the BOH. Health Director has commented that he's seen this application 3x prior, BOH rejected this idea. For the money (35-38k) it's the most Cost effective way for City to prevent mosquito borne illnesses (EEE, etc). Committee offered to work towards posting a local opt-out form (in addition to state form), but then Covid hit, and progress ceased.
