HIGH SCHOOL MATH TECHNOLOGY PRESENTATION:

Kevin Sheridan, Newburyport High School Math Teacher shared with the School Committee instructional technology best practices that were utilized during this challenging school year. The High School's math department piloted an iPad Pro technology platform. It consisted of the following:

- Spring 2020 preparing for 2020-2021 school year
 Apple teacher certification and iPad Professional development

FACE COVERINGS

Section E: Support Services File: EBCFA

The Newburyport School District is committed to providing a safe environment in schools during the ongoing COVID-19 pandemic. Maintaining a safe environment is critical to the District's ability to maintain a full-time in person classroom learning experience.

According to public health experts, one of the best ways to stop the spread of coronavirus and to keep members of our school community safe, is the use of face masks or face coverings. Therefore, using the guidance and recommendations from the Center for Disease Control (CDC), the Department of Elementary and Secondary Education (DESE) and the Massachusetts Department of Public Health (DPH), the District has established the following requirements which will remain in place until further notice.

A face covering that covers the nose and mouth must be worn by all individuals in school buildings and on school transportation. Face coverings must also be worn outside when social distancing cannot be observed.

Masks or face coverings will not be required for anyone who has a medical, behavioral or other challenge making it unsafe to wear a face mask or face covering. A written note from a physician is required for a requested exemption. Parents may not excuse their child from the face mask requirement by signing a waiver.

Additionally, face masks or face coverings will not be required when appropriate social distancing is enforced: during mask breaks, while eating or drinking, during physical education classes or while outside.

Exceptions to this policy under certain circumstances, such as for students with medical, behavioral or other challenges who are unable to wear masks, must be approved by the building principal in consultation with the school nurse or local Board of Health. Face shields or physical barriers may provide an alternative in some instances.

A student's mask or face covering is to be provided by the student's family. Staff members are responsible for providing their own face coverings. However, the district will supply disposable face covering for individuals who arrive at a building, or board school transportation, without one.

If students are in violation of this policy, the building principal will consult with the parent/guardians to determine whether an exception is appropriate, or the student may be removed from the school building for in-person learning until such time as they can comply with the requirement, or the requirement is lifted.

Violations of this policy by staff will be handled in the same manner as other violations of School Committee policy.

Visitors in violation of this policy will be denied entry to the school/district facility.

This policy will remain in place until rescinded by the School Committee. We will revisit this policy in October, following DESE guidelines, advice of our Medical Advisory Committee and the local Board of Health.

CALL TO ORDER:

Steve Cole made the motion to call the meeting to order at 8:05 AM. Motion was seconded by Bruce Menin. Motion passed 4-0.

TRANSFERS

July and August transfers were reviewed. There were 4 budget corrections. Funds were placed into the incorrect org/obj when the budget was entered into MUNIS. There were five budget line transfers: One for the Noch and four for the high school. All requests were to move budgeted amounts to other expense lines to more properly reflect for what the funds are to be used. All of the transfers were approved.

Discussion ensued about the transfer approval process and the pros and cons of the current practice. Phil was requested to draft a proposed Budget Transfer Policy by September 7. The proposed policy will be brought up as new business at the September 7, School Committee meeting with the expectation it will be sent to the policy sub-committee.

FY21 UPDATE

FY21 is almost ready to close. The last payroll that included FY21 salary expenses was the August 19 payroll. There are still a few FY21 outstanding invoices to be processed before the end of year roll process can be performed.

EXPECTATIONS

There was discussion around what type of reporting the committee would like to see and at what intervals. Phil suggested that quarterly reporting. Phil discussed the challenge of providing actual salary expenses as expenses are on a cash and not accrual basis. Several budget areas were highlighted that will be reported on more frequently: food service, special ed (out of district tuition), substitutes.

Bruce Menin made the motion to adjourn at 9:05 AM. Motion was seconded by Steve Cole. Motion passed 4-0.
