Minimum Residential Factor

- A Residential Factor of 1 and raising the levy by 1.00% would yield a single tax rate of \$12.64 per thousand dollars of value.
- Tax Levy: \$61,029,115 / Value: \$4,828,252,824 = (0.01264) X 1000 = Single
 Tax Rate of \$12.64.
- Chapter 200 allows Newburyport to select a factor less than 1 for the residential class, thereby shifting more of the tax burden onto the CIP classes of properties.
- Since 1918 Newburyport has chosen to adopt a MRF of 1 except for Fiscal Year 1986 when a shift to 1.50 of the CIP class was adopted.

For Fiscal Year 2021, we recommend establishing a tax rate of \$12.64 per \$1,000 based on a tax levy of \$61,052,933 and a city-wide valuation of \$4,828,252,824. This tax rate represents a 1.0% increase to the prior year levy limit compared to the 2.5% increase provided by Proposition 2½, which results in a decrease to the tax rate of \$0.20 per \$1,000 compared to the FY2020 tax rate of \$12.84.

Based on the FY2021 valuation, the average single-family home in Newburyport is now assessed at \$640,800, compared to \$617,500 in FY2020. This results in an average single-family tax bill of \$8,100, which represents a 2.2%, or \$171, increase over FY2020's average single-family tax bill. It is worth noting, however, that the change in tax bill for any given household will vary depending on the change in their home's assessed value, including whether or not any improvements were made over the course of the year. For FY2021, the *median* tax bill increase for a single-family home is 1.0%; in other words, half of owners will see their tax bill change by less than 1.0% and half will see an increase of greater than 1.0%.


Our ability to tax below the full levy limit is driven by five factors:

- 1. State Aid (+\$305,474): This increase is based on recently updated state aid estimates resulting from the Governor's revised budget proposal.
- 2. New Growth (+\$275,830): The Department of Revenue certified the City's FY2021 new growth value at \$925,830 compared to the \$650,000 estimate that was used to build the budget.
- 3. Reserve for Abatements (+\$124,751): The amount reserved for abatements and exemptions was decreased due to an available balance from prior fiscal years.
- 4. Unappropriated Amounts (+\$97,928): This reflects the net amount remaining after the \$115,928 in budget reductions and the \$18,000 supplemental appropriation.
- 5. Revised Local Receipts (+\$51,729): The revenue estimate for local receipts was updated based on updated figures and year-to-date activity.

In total, these factors result in excess levy capacity of approximately \$870,000 that could be taxed for FY2021 under Proposition 2½. While I am cognizant of the need for additional revenue to fund important programs and services throughout the City, including investments in infrastructure, streets and sidewalks, we must also balance this with the financial impact that the ongoing pandemic has had on many households and businesses in our community. Newburyport is fortunate to have one of the lowest unemployment rates in the region. However, at 6.9% as of September, the unemployment rate is still 4.9% higher than it was at this point last year despite going down by 6.6% from the peak in June.

I am hopeful that this tax rate proposal will provide some relief to households and businesses as we wait on additional support from the state and federal government for those struggling to get by.

AN ORDINANCE TO ESTABLISH POSTED COMMERCIAL TRUCK ROUTES AND FOR PETITIONING MASSDOT TO ALLOW FURTHER REGULATION

Be it ordained by the City Council of the City of Newburyport as follows:

WHEREAS, The City of Newburyport is committed to reducing the adverse impacts of commercial truck traffic, including noise and vibrations, on its residents while ensuring the continued, reasonable delivery of goods and services to businesses and residences in the City;

WHEREAS, Authority to restrict commercial truck traffic derives from Chapter 85 of the Massachusetts General Laws and the 2006 Massachusetts Amendment to the 2003 Manual on Uniform Traffic Control Devices (MUTCD) Section 11A-9;

WHEREAS, Federal and state numbered routes through Newburyport are open to commercial truck traffic at all times, including: Federal Route 1 (including Winter Street and Summer Streett), Federal Route 1A (portions of High Street and State Street), and State Route 113 (Storey Avenue and portion of High Street);

WHEREAS, While commercial trucks are permitted on any municipal way in Newburyport if they have a destination on that municipal way or a nearby municipal way, all commercial trucks are encouraged to use the system of Posted Truck Routes for the majority of every trip;

WHEREAS, The City is required to receive written permission from the Massachusetts Department of Transportation (MassDOT) to exclude commercially plated trucks from specific municipal ways; and

WHEREAS, Key criteria to exclude commercial truck traffic from a municipal way include the availability of a suitable alternative route, and one or more of the following:

- There is at least five percent (5%) commercial vehicle traffic on such way;
- Heavy wheel loads will result in severe deterioration of the way; and/or
- Land use along the way is primarily residential, and the municipality has requested exclusion only during hours of darkness.

NOW, THEREFORE, the Code of Ordinances, City of Newburyport, Massachusetts, is hereby amended by adding a new Division 8. – *Commercial Trucks* to Article IV. – *Specific Street Schedules* of Chapter 13 – *Traffic and Motor Vehicles*, as follows:

Sec. 13-190. - Posted commercial truck routes.

The Posted Truck Routes in Newburyport shall be:

- a. <u>Upalong / Downalong Streets</u>: Storey Avenue, Ferry Road, High Street, Low Street, Merrimac Street, and Water Street.
- b. <u>Cross Streets</u>: Spofford Street, Hale Street, Graf Road, Parker Street, Green Street, and State Street.
- c. <u>Business Park Streets</u>: Malcolm Hoyt Drive, Perry Way, New Pasture Road, Opportunity Way, Mulliken Way, Perkins Way, Stanley Tucker Drive, and Preble Road.

Sec. 13-191. – Petitions to limit commercial trucks.

By order, a majority of the city council may authorize the department of public services to petition the Massachusetts Department of Transportation (MassDOT) to exclude from specific municipal ways in Newburyport commercial trucks over a specified gross vehicle weight (GVW), during specific hours or at all times. The department of public services shall maintain and cause to be posted on the city website a list of any municipal ways for which such a petition has been approved.

 Saturday from May 1 through September 30, excepting Sundays and holidays throughout the year, and unless the vehicle properly displays a parking permit authorized by this section has been validly issued for the parked vehicle.

AN ORDINANCE TO AMEND THE MUNICIPAL CODE WITH RESPECT TO THE SENIOR CITIZEN PROPERTY TAX WORK-OFF PROGRAM

Be it ordained by the City Council of the City of Newburyport as follows:


Amend Section 2-86 – "Senior citizen tax incentive program," as follows, with deletions double striken-through in bold, and additions double-underlined and in bold:

Sec. 2-86. - Senior citizen tax incentive property tax work-off program.

The City Council of the City of Newburyport accept the provisions of M.G.L.A., c. 59, § 5K for the purpose of entitling eligible senior citizens over the age of 60 to receive a maximum benefit of one thousand dollars (\$1,000.00) off their property tax bills in exchange for providing volunteer service to the city at a rate no more than the current minimum wage of the commonwealth. This program is to be administered by the mayor's office, in conjunction with the council on aging.

Pursuant to the provisions of M.G.L.A., ch.59 § 5K, homeowners who are age 60 or over are provided the opportunity to participate in the senior citizen property tax work-off program. Under the program, participating taxpayers volunteer their services to the city in exchange for a reduction in their tax bills. Participants in the program are compensated for services at an hourly rate equal to the current minimum wage of the commonwealth. The maximum amount of the abatement shall be \$1,500 per fiscal year. This program is administered by the mayor's office, in conjunction with the director of council on aging.

I hereby submit a FY2021 supplemental budget totaling \$18,000 in proposed expenditures. This request funds higher than projected enrollment for Newburyport students attending Essex North Shore Agricultural & Technical School. Newburyport currently has five students enrolled at Essex Tech; areas of study include: equine sciences (3), environmental technology (1) and veterinary science (1).

This request is offset by the decrease to the assessment for Whittier Tech. As you know, the Whittier assessment went down by \$22,306 as a result of their School Committee's September budget revision. Following this final supplemental budget request, available revenue will remain from City Council budget reductions, as well as, recently updated state aid estimates following the release of the Governor's Revised FY2021 Budget Proposal (Revised House 2).

The ongoing pandemic has had significant financial impacts on many households and businesses in our community. As such, it is my intent that we retain the remaining revenue as a means of defraying the amount of taxes that need to be raised for FY2021. My Finance Team is working with the Department of Revenue on certifying values and anticipates submitting a FY2021 tax rate proposal for the City Council's November 9, 2020 meeting packet.

AN ORDINANCE RE ENFORCEMENT OF THE STATE BUILDING CODE

Be it ordained by the City Council of the City of Newburyport as follows:

Amend existing Chapter 5-61 of the Newburyport Code, as follows, with additions <u>double-underlined and italicized</u>, and deletions stricken through:

Sec. 5-61. — State Building CodeAdoption of BOCA Abridged Building Code.

As provided under section 3A of chapter 143 of the Massachusetts general laws: The BOCA Abridged Building Code (Fourth Edition 1965) issued by the Building Officials Conference of America, Inc., together with the 1967 accumulative supplement thereto, copies of which are on file in the office of the city clerk, issued by the Building Officials Conference of America, Inc., are made a part of the public records of the city, and are hereby adopted by reference the same as if fully set out herein, except as amended in this chapter.

- A. State building code. Unless otherwise provided by the state building code (title 780 of the Code of Massachusetts Regulations), the city's inspector of buildings shall enforce the state building code as to any building or structure within the city, including any building or structure owned by any authority established by the general court but not owned in whole or in part by the commonwealth, and the state building code shall be the code for all buildings and structures within the city.
- B. <u>Historic preservation</u>. In the event of a conflict between the code and a statute, ordinance or bylaw regulating an historic district, regional historic district or architecturally controlled district, the statute, ordinance or bylaw regulating exterior architectural features within that district shall prevail.
- C. <u>Commonwealth buildings or structures.</u> The city's inspector of buildings shall enforce the state building code as to any building or structure within any city that is owned in whole or in part by the commonwealth or any departments, commissions, agencies or authorities of the commonwealth.

It is with great pleasure I submit the Newburyport Climate Resiliency Plan. This plan was developed by the ad hoc Resiliency Committee that worked diligently over the past several years to develop a plan that will guide our community in preparing for storm surge, seal level rise and climate change impacts.

The plan is built on previous studies and our Municipal Vulnerability Preparedness (MVP) findings. The report begins with an overview of the City of Newburyport, infrastructure and resiliency planning to date. Climate Change Hazards Assessment (Chapter 1) provide details on sea level rise, coastal storms, heavy precipitation, flooding, wind, tornados, weather extremes, insect disease vectors and combined sewer overflows. This is followed by Vulnerability Assessment (Chapter 2) detailed for each of the above events, Adaptation Strategies (Chapter 3) and Implementation (Chapter 4). The report provides seven appendices with supportive documentation and over one hundred tables, charts and photos.

I congratulate the ad hoc Resiliency Committee for their extensive time commitment, deep research and well-developed plan for our city. Please see the attached Executive Summary. We are planning to present the plan to the public in coordination with Storm Surge early in the new calendar year.
