- SZ ViewPoint shows many balances
- AK They have a 2022 AHT strategic plan

Been a challenge to get people who can do that. American Steeple Company. They were phasing it out. The 101K is the total project and will be phased over two years. \$20k more to finish – hope to raise it elsewhere.
