- EM Method of budgeting has tightened up so there is less flex built in
- This explains why what is left is basically approaching 100%
- Most of the turn backs were staff vacancies
- Prop tax large DOR directives utilities methodology for assessment and the way that the way 2 family homes get assessed
- Other Excise Rooms tax mostly returning back to pre-covid and then STRU fees
- 7 to 128 STRU operating.
- DOR does not tell us what the breakdown is of STRU
- STRU 5.7 to state, 6 to city, and then another 3 is possible (local option)
- Tax title fees down, function of better collections
- Lic. Commission talking about reinstating the fees now that pandemic is over
- Medicaid prior year reimbursement
- Misc Non-Recur Tailing adjustments, Sick leave reimbursement, etc
- Misc Non recur goes to general fund
- State aid came in slightly better than expected
- \$2.1 in excess revenue from what was budgeted
- Enterprise funds had a good year last year, higher use of water and higher use of boating. Funds were up a lot (>10%). Now down 2-5% as they normalize.
- Sewer outpaced water because of insurance payout on generator payment
- Free cash started at 2.68 and ended at 1.104M
- We expect to roughly get a free cash 4m of free cash overall
- ARPA now sitting at approx. \$2m to spend down that balance
- ARPA 12/31/24
- Bonded part of the Fire Station. Up to \$10m is considered tax free. To the extent \$10m.
