- Susanne Cameron
- SC developing a new program. Have existing for 80% AMI and only for deed restricted properties.
- SC Thinks we can have a new source funds, available up to 100% of AMI. This would be middle income. This would be for any market rate. Maybe allow someone renting to move up to ownership.
- SC Program would have 10-12 families and it is flying out the door. Interest rate environment is stubborn. Funds could be used. It is a forgivable grant then the grant is forbidden. If they move within years 1 to 5 then it gets clawed up.
- SC Asset limit of \$75k
- SC First come, first serve in terms.
- SC Family of 4, Essex County, no more \$140,200
- AK Has this been offered before?
- SC Yes, other places do have this.

This is now in the rec category.
