COMM00531_01_29_2024 FY2024 Mid-Year Budget Report

- EM
 - o Right where we've been for most years
 - Running right around the 50% for both except for Harbormaster due to timing
 - o Fairly typical numbers
 - o Revenue is right where expected for the most part
 - Legal possibly from Whittier
 - MV Excise down to reduction in new cars being purchased
 - Meals is up consistent with inflation
 - Room Occupancy STRU is showing itself here
 - $\circ~$ Fees are down 44% goes up and down depends on tax title
 - Building Permits up a lot fluctuates, timing
 - Some new construction but nothing too big
 - o Investment income is way up because of where rates are
 - o About 5% returns
 - Water/Sewer/Harbor are all down. They have all collected 50% of their estimate. Also included a visual. Rainy season, not using as much water.
 - Previous year was up a lot
 - General fund up 4.6%, total budget up 2.2%
 - Free cash current based on submitted \$2.3M
 - o Water 1.1M, Sewer is 1.7m, Harbor 846k
 - Stabilization 4.5m
 - Available from ARPA 1.2m

- BH Is there a target for stabilization
- EM yes 5% of revenues
- EM Around 5.5% right now
- BH On Water and Sewer, right on the line
- EM Use retained earnings or some off cycle rate increase or general fund
- BH ARPA spent by 12/31/24
- SZ Can water and sewer consultant tie back to rates?
- **EM –** not spending less, just budgeting
- SZ parklets from fund
- EM yes, we can work with the Council, work on the fees
- **MW** Are we any closer to having a real cost for parklets
- **EM –** Guesstimating and subsidizing, particularly DPS time
- EM bottom line we weren't covering cost
- SZ what does it make next year

- **EM –** pretty stable for revenue, no new fees
- EM Based on similar revenue, but cost pressures
- Jane Snow 9 Coffin St. One of things that was concerned was about parking spaces. Walked around all the streets and how much we lost. Understand the balance. City was paying for flower and having them watered. Should up be up owner. Residents should not be paid. STRU what is happening
- **EM** could be staffing who knows but right now this is just potential

TRAN00177_01_29_2024 Mayor: General Fund Free Cash \$27,046 to Fire: Injuredon-Duty \$27,046 (COTW)

- Original transfer got us through first 6 months
- There is an accidental retirement, this is before the retirement board.
- Requires 3 medical exams, they have been completed as of 1/25
- They have 30 days to respond (physicians) through Perac
- The board will then review and then act on disability
- By end of March, expect to have better update in terms of long term.
- Retirement can either approve or denied by board
 - Approved would give 73% salary of highest salary before they left tax free. For the rest of their life. Option C would go onto any beneficiary. Would be paid for from retirement.
 - Deny Applicant has right to appeal. Based on law, former chief would be on injured on leave status. Would continue until his retirement caps out (age 65).
 - City deems injured on duty status to be no longer applicable
- BH how long does this go?
- EM 3/31 this transfer
- EM End of February reports back then board has to hear back
- EM Very likely that could need more
- BH is any of this coming back to us
- EM Insurance covers \$1k/week, net is charged to budget
- EC What is the decision criteria
- EM This is all part of accidental retirement part of injury sustained on duty. If the 3 member medical panel comes back and all say it's an accident then the board really needs to heed the outcome. If Medicare came back unfavorably.
- SZ What is typical percentage
- EM depends on age and service. Max is 80%. Taxable under regular retirement. Accidental disability takes out the age factor and takes out years of service and just goes to 73% of where you left off.
- SZ What would have been liability

- EM Would not have been 73%. Service was relatively short for this employee.
- SZ Can they can come in and ask for ask for creditable for service
- SZ will we see it immediately in retirement
- EM it would take a couple of years after that.
- SZ is there a negotiation
- EM can discuss
- SZ Really torn on this. This may be the last one
- MW Between rock and hard place
- MW Would be helpful to have a dollar value for each pathway
- MW By waiting a month, we'll have more information.
- MW Wait until they make their determination
- BH Fresh perspective of not having approved before, I'm inclined to allow process its course but may need to take a different approach.
- EC If we do not approve, do we keep paying, you've got to come up with it from some other source.
- EM If we don't have appropriation then we can't pay it. Eventually will catch up.
- EM given risk, would be to err on the side of caution
- EC if we don't and not paying it and may have some exposure
- EM Approve the transfer
- EC We aren't specialists so we should defer to the process
