## • ORDR00533 01 29 2024 NHS Statement of Interest Vote (COTW)

- Steve Bergholm provided an intro
- Provided slides that can be posted
- Accelerated Repair Program (ARP) requirements, 25 years for roofs, 30 years for windows, 250k
- Fund schematic design within 90 days
- If we get in invitation would be October of this year
- Timeline would be provided
- Newburyport reimbursement would be about 43%
- Each application is technically separate but likely to go together
- AK Saw this on the 5<sup>th</sup> on the SC
- AK Couple of steps ahead of submittal
- AK Whittier example, critical to understand finance component
- AK Doesn't mean that we are committing, to enter the process
- AK The costs that we have here, those estimates are rough
- SB estimates are based on info from MSBA itself, \$50/sf
- SB These are based on \$55 to project some escalation
- SB Also reached out to a project company to townsend company that is working on fire station Keery was project manager and asked them
- AK Know that there is bundling with HVAC equipment. Once this roof is repaired, what happens. Systems like this are no part of project
- SB no not mechnicals
- AK You don't need to upgrade systems at same time. HS only as small equipment
- SB CIP will show something for HVAC system
- AK Should we pay attention to MSBA application or same as last time
- AK this has details etc
- SB This was not forwarded to us

- BH very thorough, do want to say that the numbers that we are given. Add up to 5.5m for cost estimate
- SB SOI is only Building A HS and then all of the middle school, \$2m for HS and 1.8m for middle school
- SB Building B will have to be separate SOI down the road
- BH reimbursement
- SB about 43.6%
- BH Reference in application manpower and other expense
- BH Do we have any numbers on that
- SB It's not a big number we've had roofing contractor out 3 times for \$1k each time. Sometimes its maintenance people
- SB City Council approved \$20k for roof repairs some years ago, spent about 2/3rds of it to this point
- BH What is level urgency if we don't get in
- SB in Capital plan, recommend design and management funds I think we should go for project even without MSBA. It is aging and time to move forward. If we push it another year then we're pushing out luck.
- BH Experience working through MSBA?
- SB Have been through this for a long time, dating back to 2007
- BH Did see a reference to windows
- BH is this is only for the roof?
- SB focusing on the roof. Windows in both schools are not old enough to qualify.
  Middle school windows are fine. HS windows have some problems but not a major problem at this point
- CP Looking through the SOI it says end of pg 4. No more than 1 prioritized are we having more than 1 then?
- SB I believe it is 1 per building? You can have to designate one of the SOIs are your priority. We are designated the high school. Doesn't mean we can't submit another one.
- SZ MSBA have more requirements
- SB procurement the same, OPM
- SB they do make you jump through more hoops, more of a process more time consuming to work with them
- SB Schematic design is 2-2.5% maybe, it would be 70k.
- SB If you get in you have to work with their firm and design. If you did it on your own. So you can't get a head start
- SZ Are there tarps
- SB yes, we have some tarps, we have some seats roped off. Plaster has loosened up
- SB Most of the dampness is out of the way, closets, etc.
- SZ any idea on chances
- SB they paused last year but more funding this year

- Jm any other money
- SB some at middle school
- JM air quality
- SB no issues or complaints
- SB yes timeline is 26 27, sooner if we go without MSBA
- Numbers in scan are updated
- Motion to recommend approval collectively 533, BH/AK
- SZ I will support but feeling heartburn
- AK first time for ARP?
- SB we did it once before
- AK when I go to MSBA website, we've only had 2 done
- AK we've only had 2
