- Paul has done a good job with software

- Wanted to put a form in place similar to Gloucester
- Not revenue generating, just making sure that people are turning this in.
- Materials are being monitored, that permits are pulled for electricity, etc
- Permit or checklist for marinas may be something that is discussed in the future, getting input.
- Have been using this for 10a
- They have been debating if there is going to be a fee for this
- If you don't have a dock but you are on the river but you can apply and steps to go through
- Have a few ownership changes
- JM yes this could be if homes are bought and sold
- AK Where are we talking about
- JK Off Merrimac for example, Jefferson Ct., etc
- AK Why did this come up again?

- JK Want to make sure that people are in compliance with waterways permits
- AK Why \$50?
- JK Gloucster charges per sq foot, max \$400
- JK We don't want this to be revenue, more compliance standpoint
- o JK If you're putting out docks, \$50 is not huge fee
- AK What is average size

### ORDR00545\_03\_11\_2024 School Security Upgrades Lease Order \$731,343.00 (COTW)

#### March 11, 2024 - Committee Amendments 3/28/2024

**THAT**, the City Council of the City of Newburyport, in accordance with M.G.L. c. 44, §21C and upon the recommendation of the Mayor, hereby authorizes the following lease purchase financing agreements for the acquisition of equipment that may be acquired through the issuance of debt under M.G.L. c. 44 or improvement of a capital asset the improvement of which may be financed by the issuance of debt under M.G.L. c. 44, the term of such agreement not to exceed the useful life of the equipment or improvement as determined by the Mayor, and to authorize the departments specified below to enter into such agreements on behalf of the City or to take any other action relative thereto. <u>While all such agreements shall be general</u> <u>obligations of the City, it is the intent that all payments made in connection with said</u> <u>agreements shall be identified and paid for from the school budget.</u>

And Furthermore THAT, by approval of this agreement for the aforementioned school security equipment, the City Council, in accordance with Newburyport Code of Ordinances Article 1, Sec 12-10, authorizes Deployment of security camera's on school property at Newburyport High School, the Bresnahan, The Nock and Molin schools, consistent with the submitted proposal. Placement of cameras, access to, and handling of data including images is to be managed in Compliance with the district's security policy as approved by the Newburyport School Committee on 3/27/2018, and Revised on 10/2/2023. This policy may be updated and reapproved from time to time.
