APPT 446 - Elaine Nickerson, AHT

Ms. Nickerson spoke to her time in Westford as a member of their Affordable Housing Committee (2001-2007) and the Trust (2002-2006). Westford had Habitat for Humanity and 40B projects their committee supported building in town She took a leave from working on the Westford AHT to start her own consulting firm that focused on affordable housing, mainly in the post development of a project. She did this to avoid any conflict of interest. At this same time she had a cottage on Plum Island and came to Newburyport in the summertime for 25 years. She moved to Newburyport permanently and retired at the beginning of Covid from her consulting firm. She wants to use her experience on the AHT in Newburyport.

Cllr. Preston moved to approve the appointment. Cllr. Wright was the second. Committee voted 3-0 to approve APPT0446 to the full council.

APPT 448 - Biff Bouse, Historic Commission representative on the CPC

Mr. Bouse is a native Nebraskan. Came to Newburyport in 2018. Went to Vassar and Harvard for urban planning and design. Was impressed with Newburyport's history in being able to stop urban renewal from destroying historic downtown. Loves the historic buildings and homes in the community. Stated standing in Newburyport's historic council chambers generates a "feeling of what a good city should be like." This is what got him interested in the history of the city. He started watching historic commission meetings. Stated being on the historic commission "at least made my mom feel good for doing something he went to school for". He has served as the vice chair of the historic commission and was happy to step up to be the commission's representative on the CPC.

Cllr. Preston follows Mr. Bouse's Instagram account on historical Newburyport and asked questions regarding his criticism of some of our zoning. Mr. Bouse stated his concerns for what "historic" means in the community, referencing some cases where homes that are 75 years old are being torn down to

Public Comment: none

Cllr. Preston moved to approve the appointment. Cllr. Wright was the second. Committee voted 3-0 to approve APPT448 to the full council.

APPT 449 & APPT. 450 – Tom O'Brien – Housing Authority (reappointment) and Housing Authority Rep. to the CPC (appointment)

Mr. O'Brien has been a member of the Housing Authority since 1995. Housing Authority consists of Kelleher Gardens and the Sullivan Building. He spoke to the great people he works with at the Housing Authority. Spoke to the improvements being made at Kelleher Gardens (siding improvements). Has enjoyed being a member and was happy to step up to be the representative to the CDC. Mr. O'Brien was a member of the city council for 22 years, water commission for 6 years (prior to being on council) and the water and sewer the last 2 years.

Cllr. Preston asked questions on the housing authority history.

Director Port spoke to the creation of the housing authority.

Council President Cameron spoke to the membership being 4 appointments from the city and one by the governor. The Housing authority is funded predominately through the federal government and some from the state. The city does not typically provide funding to the authority. Cllr. Donahue asked questions regarding the upkeep of the Sullivan Building.

Cllr. Preston moved to approve the appointment. Cllr. Wright was the second. Committee voted 3-0 to approve, collectively, APPT449 & APPT450 to the full council.

APPT453 Denis Morel, Building Inspector

Mr. Morel has been the city's building inspector for the last three years. Has enjoyed working with the people in the building department. He's also enjoyed working with the folks on the commission on disabilities.

- Kristen Farell 28 Spotford Street Co-chair of the Commission on Disabilities, has been on the commission for 10 years. Stated Mr. Morel has been an excellent person to work with as building inspector and ADA coordinator, one of the most accessible members on the city's staff. Stated his excellent communication skills are brought to his job every day. Brings his knowledge of ADA ad building codes to his job.
- Cllr. Jennie Donahue spoke on behalf of Mr. Morel stating he brings great ideas and enthusiasm when he works with the commission and enthusiastically supported his reappointment.
