Dear Andy, Newburyport Zoning Board and Historical Committee members,

I am writing in recognition of the ongoing delay, committee meetings, and necessary decisions related to Michael and Tracy Gray's house construction on Harrison Street. As a resident of Harrison Street who lives directly across the street from this property, I strongly advocate for a resolution that allows for construction of the house to be completed.

This project (and frankly eyesore) has been ongoing for too long. I understand that certain construction restrictions were compromised during the initial part of the project, but the current freeze on further construction does nothing to benefit the city, its residents, the many visitors to the rail trail or the property owners. Importantly, our neighborhood is one that takes pride in maintaining, and enhancing, its appearance - including collectively helping to maintain the area of the rail trail adjacent to Harrison Street (beside the Gray's property). The stoppage of construction has significantly transformed this and turned our small street into one with an indefinite construction site.

If construction of the Gray's house is to be permitted, then there is no recognizable benefit to further delaying its completion. I, and at least most, if not all, of my neighbors, a) very much hope for project completion and b) believe that the resulting house will be an improvement over the former house. Not to be overly critical, but the former house did not appear to be definitionally, structurally or aesthetically representative of an area historical house.
