Please note that the Institution for Savings (the applicant) is proposing the construction of a two-story 8,880 SF addition to the rear of the building. This new addition will be to the newer portion of the existing building built in 1980. The property is located in the B2 zoning district and the Downtown Overlay District (DOD) at the corner of State and Prospect Streets.

This new addition is triggering Major Site Plan Review given that the construction is over 1,000 SF.
