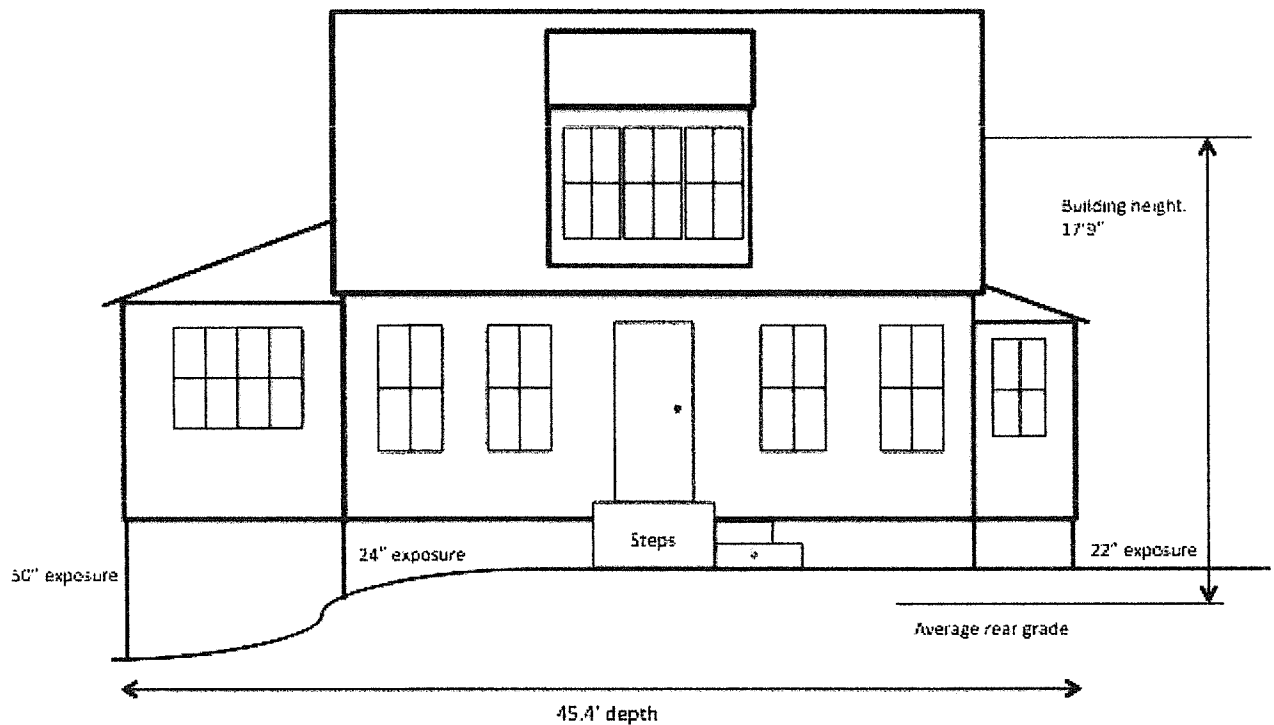

11 Coffins Existing House Elevations

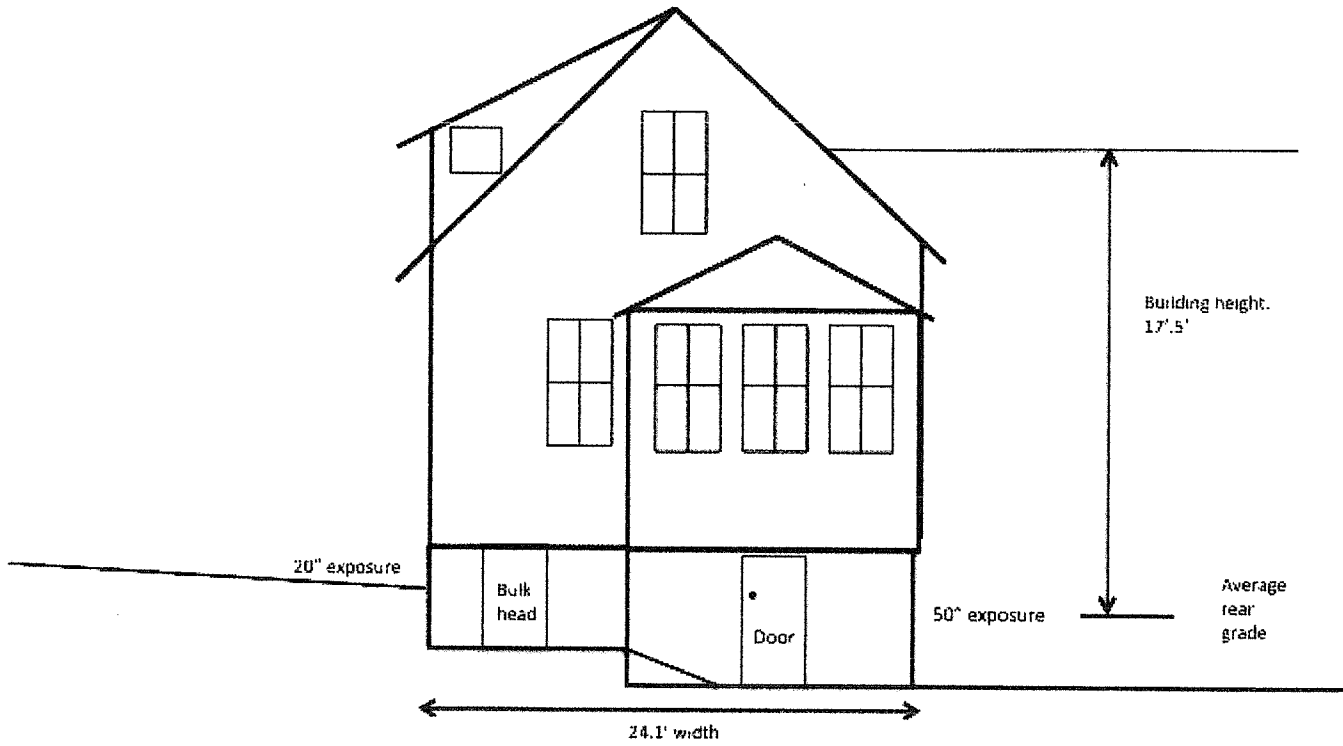

11 Coffins Existing House Elevations

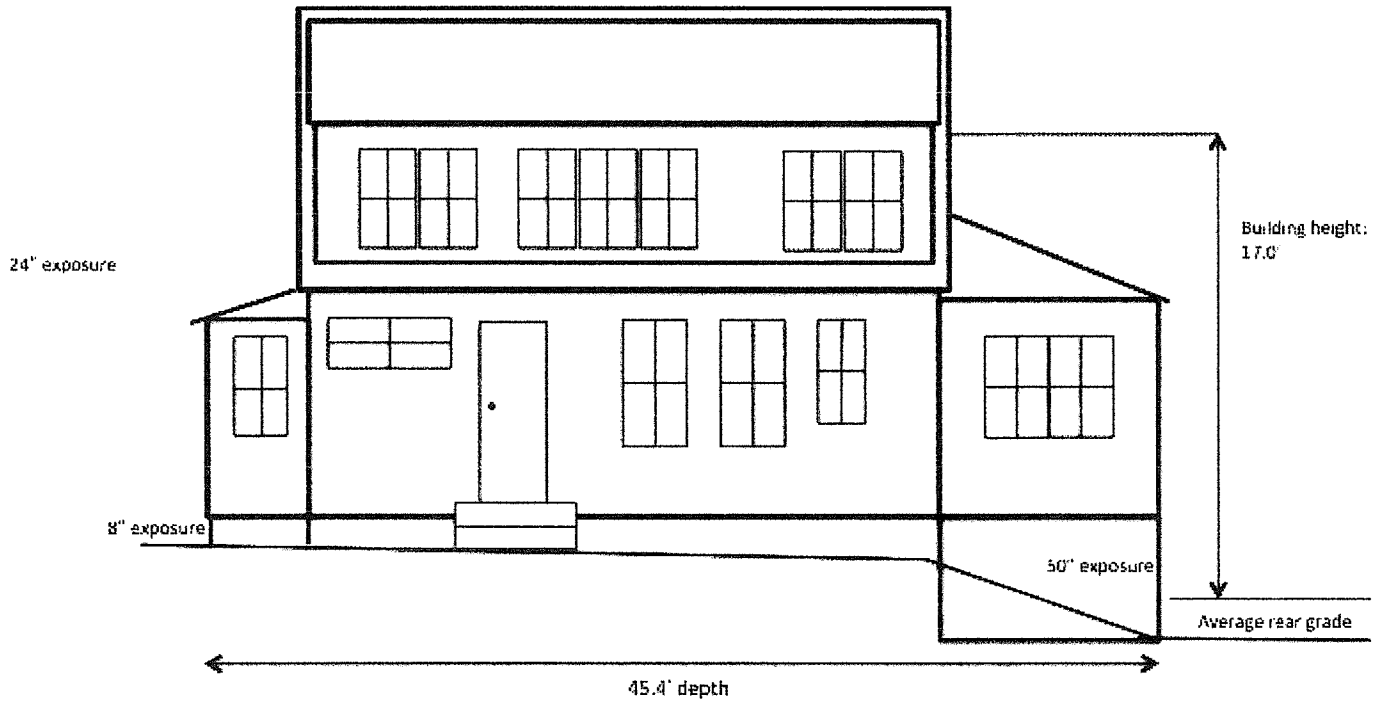

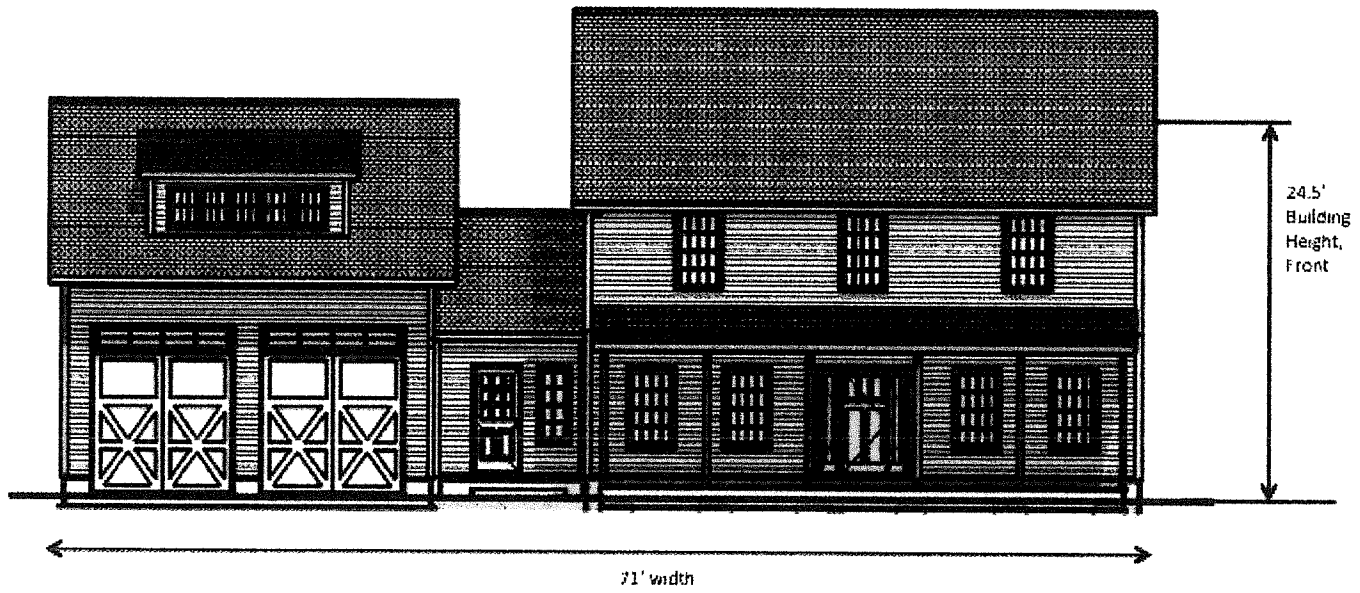

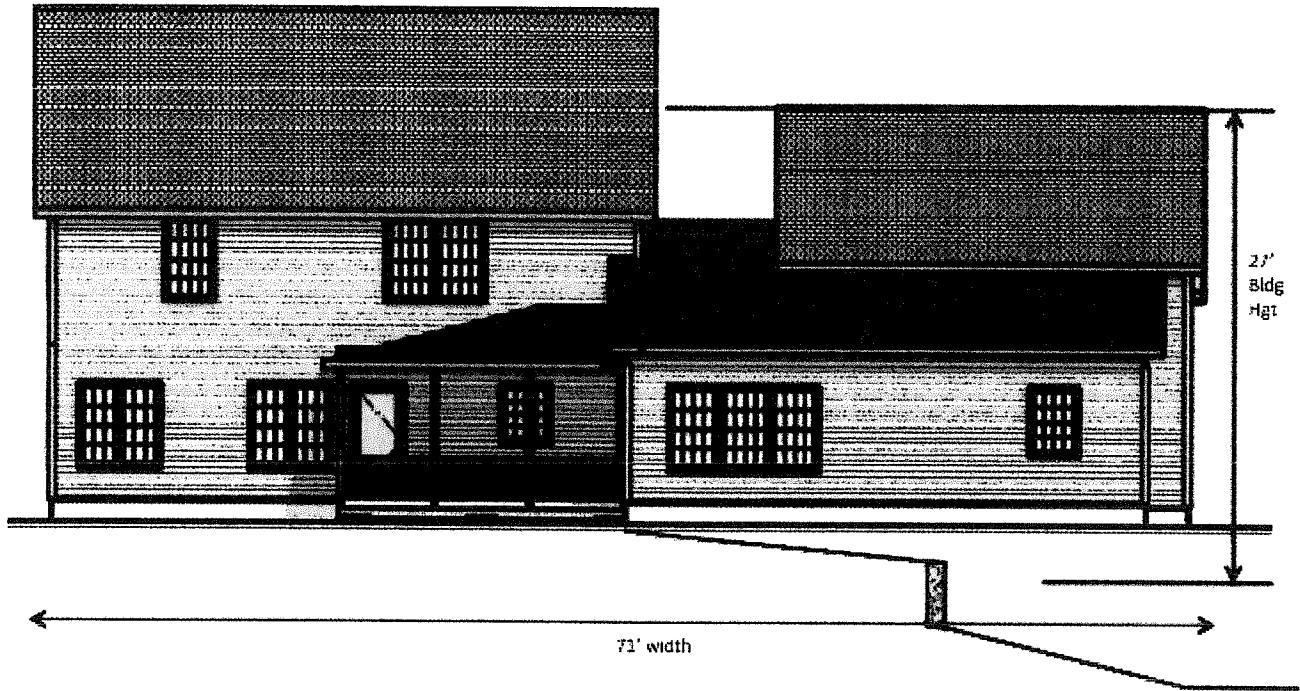

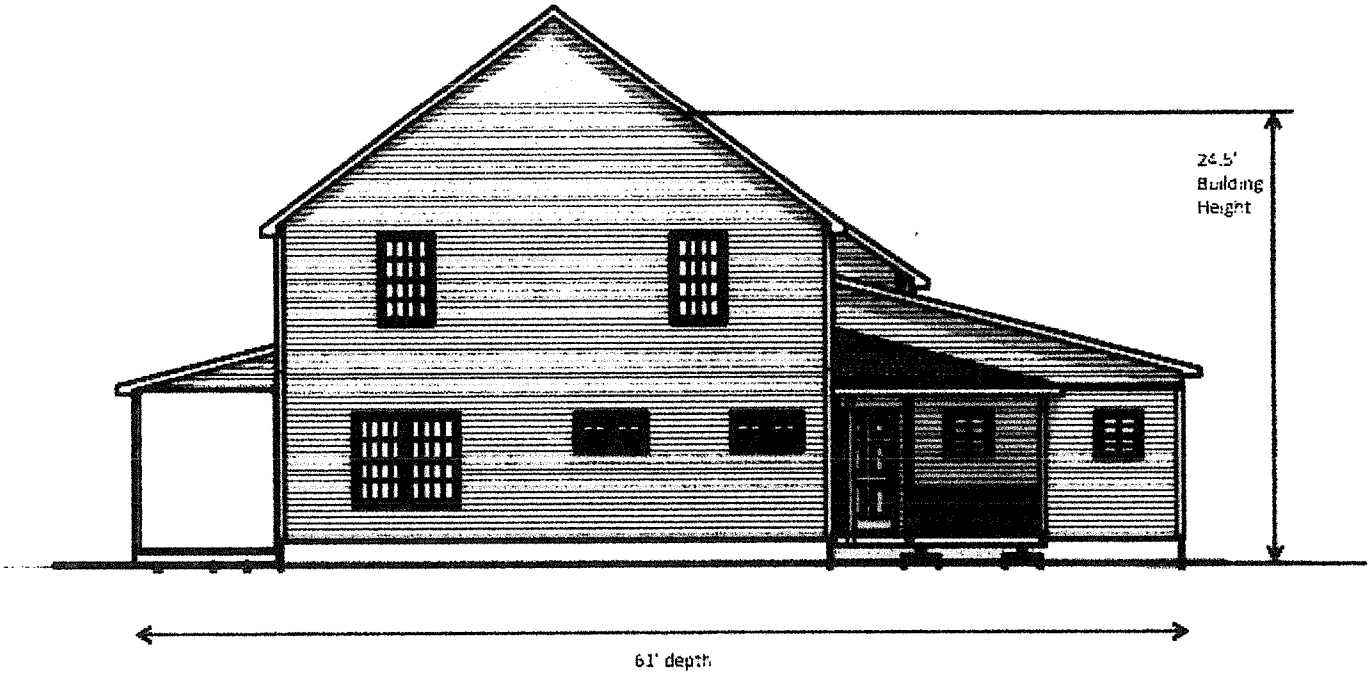
