<u>The Heritage Trees</u> of Oak Hill Cemetery are some of the largest and oldest in Newburyport. The rural garden cemetery was designed by local citizens who secured funds and planted over 260 species of shrubs, trees, and flowers during the 1860's. Today there are over 100 trees that are at least 125 years old and the mixture of species is one of the most impressive in northern New England according to the late arborist Jeff Ott of Northeast Shade Tree.

PROJECT SUMMARY: Provide a description of the Project, including the property involved and its proposed use.

<u>Objective</u>: To preserve and prevent further deterioration of many of Newburyport's oldest and largest heritage trees

<u>Request</u>: \$10,000

Oak Hill Cemetery was consecrated in 1842 and is managed by a Board of Trustees. The burying ground is one of the first rural garden cemeteries in the country. The 30 acre cemetery comprises of over 8,000 burials and is still an active burying ground. Historic cemetery tours have been conducted since 1988, and the beautiful landscape is home to many species of birds and is a popular destination for walkers, joggers, and people conducting genealogy research.

During the past eight years, over 550 gravestones and 40 granite curbings have been restored with the assistance of Community Preservation funds.

Notable burials include photographers, artists, 29 Newburyport mayors, over 170 sea captains, authors, merchants and businessmen, and abolitionists who have made a significant contribution in shaping historic Newburyport. Published in 2009, Tiptoe Through the Tombstones, Oak Hill Cemetery, Volume I won five New England and New York Book Festivals awards.

<u>The Heritage Trees</u> of Oak Hill Cemetery are some of the largest and oldest in Newburyport. The rural garden cemetery was designed by interested citizens including Edward Strong Moseley, who guided staff in planting over 260 species of shrubs, trees, and flowers during the 1860's. Today, most of these plantings are gone but some trees remain from the late 1800's and are in need of immediate critical care. There are over 100 trees that are at least 125 years old and the mixture of species is one of the most impressive in northern New England according to the late arborist Jeff Ott of Northeast Shade Tree.

Ghlee Woodworth has raised over \$100,000 during the past 12 years to fund: Brown Chapel restoration, heritage tree preservation (CPC \$35,000), gravestone restoration, and tree planting.

The CPC grants of 2009 and 2010 preserved over 60 heritage trees. In the following years this preservation work <u>prevented</u> massive tree destruction and gravestone damage during wind storms.

During the past 5 years, \$6,000 has been dedicated to tree removal. Due to budget constraints the board has been unable to dedicate more than \$2,000/year.

Since 2015, donations and fundraisers secured \$4,400. Mayor Gayden W. Morrill Charitable Foundation contributed \$2,500 in 2019. Monies purchased and delivered 21 oak, maple and elm (2.5 caliper - 10 foot saplings). Ghlee Woodworth performed all labor of digging holes, planting, watering, etc.

The Oak Hill Cemetery project meets three Community Preservation Act purposes: historic preservation, open space, and recreation. Newburyport citizens recognize the importance of preserving local historic and natural resources and maintaining the character of the city. The cemetery is a significant part of Newburyport history.

The <u>Heritage Trees</u> date back to the late 1800's and shape the landscape, visual beauty, natural habitats, and scenic views where once tall ships could be seen entering Newburyport harbor. Today, walkers, joggers, birdwatchers, and researchers visit the cemetery for its natural beauty, historic and educational significance. Sue McGrath, Newburyport Birders, tours Oak Hill as it is one of the best local destinations, aside from Parker River Wildlife Refuge, to view bird species. Since the Clipper City Rail Trail opened along the old City Railroad adjacent to March's Hill an increase number of walkers, joggers, and bicyclists each day wander through Oak Hill Cemetery on their way to and from the rail trail.

During the next 10 years, over 50 trees could be lost due to disease and deterioration seriously affecting natural scenic views and wildlife habitats. The Proprietors of Oak Hill Cemetery will continue to preserve one of the most impressive tree stands in the community and northern New England. Additional funding will assist this goal.

Depending on recommendations of the arborist's timeline and weather the work will be completed by spring 2021.

FUNDING:

Attached is a \$2,000 Iron Tree service paid invoice of \$2,000 dated May of 2019. Generally, it costs approximately \$2,400 to \$2,500 to remove two trees. However Iron Tree staff were generous with their time and assistance. Due to cemetery budget constraints the board is only able to commit \$2,000/year. Arborists' decisions in January 2020 will most likely change in 10 months. Announcement of awards are approximately September 2020. Our plan is for arborists to walk through the cemetery in October 2020 to make recommendations for tree and/or branch removal based on 1. Safety and 2. Tree health.

The project is managed by Ghlee Woodworth and the work will be completed by spring 2021.







I am writing in support of the request for \$10,000 for the care of the existing trees in Oak Hill and planting of new ones. I hope you will give this ask serious consideration for the following reasons:

1. We are so lucky to have this <u>"rural garden cemetery"</u> in the middle of Newburyport. It is an incredible memorial to those who had the foresight to understand that cemetery land can also provide the benefit of open space to the community. To this day, it is one of the most peaceful, quiet, naturally beautiful places to walk in the City. That being said, the trees planted back in the 1800's and early 1900's are tired and ragged. They are dependent on their caretakers to keep them pruned - for their health and for the safety of visitors. See photo - rural garden

2. Along with the trees in this cemetery are all the stones and monuments dedicated to those that came long before us, as well as those more recently deceased. The stories of these people's lives hold the City's **history** through time. In its own way, Oak Hill is an archive, a place of public record, and thus fully deserving of support from Preservation monies. And if the trees are not kept healthy and well, the stones memorializing these folks are at risk of damage by falling limbs or toppling trunks. See photo two -history

And then there is the fact that we have someone in the City who is willing, able and inherently generous enough to keep a watchful eye over this **remarkably beautiful** Cemetery; to take notice of damage of tree and stone, to plan for future plantings and to make requests for the resources needed to appropriately care for "these hallowed grounds." To make money available to Oak Hill Cemetery when we know from past experience that it will be used mindfully and for the purpose stated in the application is a wise and just thing to do. We are writing to ask that you support the Oak Hill Cemetery's Heritage Tree project application for \$10,000.

Oak Hill Cemetery is a place local Newburyporters and countless others in New England and abroad enjoy for its serene beauty and historical relevance. Over the past 10 years our community has witnessed and appreciated the amazing comprehensive restoration of Oak Hill Cemetery including planting of trees, repair of gravestones, granite curbing and the revival of the stone chapel. Community interest in these efforts have increased exponentially. Presentations about Oak Hill by local historian, gravestone restoration expert and Oak Hill Cemetery steward, Ghlee Woodworrth, are very attended.

The trees in Oak Hill are spectacular. They represent some of the largest and oldest in Newburyport. Arborist report over a hundred trees reside in the 30 acre cemetery that exceed one hundred years old. Birdwatchers appreciate the vast species of feathered creatures who make these trees their homes. Walkers enjoy meandering around the trees, enjoying the transformation of colors and foliage throughout the seasons. The trees are the backbone of this amazing landscape and special attention must be given to maintain and replenish them. Over the past 5 years, in addition to a grant of \$2,500, \$4400 was raised. These funds were used to purchase 21 oak, maple and elm saplings.

In closing, the cemetery budget is small, \$2000/year. Much as been accomplished with the sweat equity of a few volunteers but the needs far exceed the budget. Your support of the Oak Hill Cemetery's Tree Project would help ensure visitors will be able to enjoy this beautiful space for years to come. Please fund this worthy project.
