## 123 State Street Overview

- Partial Building Demolition where Applicant is proposing to remove rear portion of the Structure and construct addition to replace it.
- Rear portion to be removed was not part of original structure, is constructed poorly, does not integrate well with the original structure, and is in disrepair and unsafe.
- Proposed addition entirely behind the structure and adding only an additional 466 square feet to what currently exists.
- Addition will be finished with same reveal and details appropriate for the period.


# 123 State Street Historical Overview

- House constructed in or around 1875 according to District Data Sheet and described as Second Empire Cottage.
- No Form B is available.
- Earliest Sanborn Map showing structure is from 1914.
- Form of structure on map appears similar to what exists today but viewing structure in person shows that there are two additions in form of rear bump outs.
- According to Architect William Nolan, it appears most recent addition was in 1980s based on materials used.
































Existing Exterior Elevations






