Newburyport Conservation Commission April 18, 2023 Online Meeting Minutes

1. Call to Order

Vice Chair Steve Moore called an online meeting of the Newburyport Conservation Commission to order at 6:49 p.m.

2. Roll Call

4. Old and New Business

Plum Island Updates

The dredging work has been completed. Approximately 13 acres of sand was deposited on the beach but the area is relatively flat, with the average elevation being only 2.5 meters. The contractor must submit an as-built plan showing the profiles. This spring, Greg Moore of UNH will begin a project to plant dune grass in the area through a grant from the U.S. Fish and Wildlife Service.

An Order of Conditions was issued in January 2017 for the project to repair the seawall and bulkhead. An extension was issued in January 2020 that was to have expired in January 2022 but was extended to April 25, 2023 due to the state of emergency. The applicant is seeking a one-year extension to April 25, 2024. The plantings that were installed in the summer of 2022 failed and time is needed for new plant materials to become established. This spring, the area will be planted with a native species of grass.

Tom Hughes represented the applicant. He said Phil Christensen has reviewed the stormwater details and the Planning Board has approved the project. Upon completion of the work, there would be 50,113 square feet of buffer on City land and 28,730 square feet of buffer on the project site. Of the lot as it exists now, 14.2% would be altered. After the land has been given to the City, 39% of the remaining lot would be altered.

A footbridge would be installed at the narrowest part of the stream. The flat bridge would be approximately 12 feet in length and wide enough for a four-foot mower. It would be supported by concrete blocks on either side of the stream. The pathway is not meant to be a public trail. It would be established for the purpose of providing access for the maintenance and inspection of the property. The Commission members requested that the applicant install marker posts along the boundary of the City property and the 25-foot no-disturb zone.

8. Order of Conditions Craig Pessina, Hale Business Park Realty Trust 21 Malcolm Hoyt Road

Dan Warchol moved to grant a Variance to the local ordinance for an impact of greater than 20% to the buffer zone on the site based on the conveyance of a portion of the property to the City for the benefit of the public. David Vine seconded the motion. The motion was approved by a 4-0 vote (Steve Moore, yes; Charlie Alovisetti, yes; Dan Warchol, yes; David Vine, yes).

Dan Warchol moved to issue an Order of Conditions for 21 Malcolm Hoyt Road with the special conditions that 1) prior to the initiation of work on the site, the applicant shall convey ownership of the rear lot as referenced on the project plans to the City of Newburyport for conservation purposes and prior to the transfer of the property to the City, the applicant shall establish by mowing the proposed maintenance and monitoring pathway leading from Malcolm

Hoyt Road to the upland island within the site and such pathway shall include a bridge to provide access to the site by a mower of approximately four feet in width, 2) the applicant shall install permanent markers at the boundaries of the City property as well as the boundary of the 25-foot no-disturb zone and these markers shall be presented to the Commission on a monument plan for review and approval and shall be established in the field prior to the completion of work on the site and 3) as the project has impacted greater than 20% of the pre-existing buffer zone on the site, no additional expansion of the footprint or impact of the buffer zone shall be permitted in perpetuity. David Vine seconded the motion. The motion was approved by a 4-0 vote (Steve Moore, yes; Charlie Alovisetti, yes; Dan Warchol, yes; David Vine, yes).
