1. Call to Order

Chair Joe Teixeira called an online meeting of the Newburyport Conservation Commission to order at 6:45 p.m.

The pipe for the dredging of the river has been assembled and the pumping of sand onto the beach has begun. The pipe extends from the river near the *Captain's Lady* along the top of the slope to 75th Street. The beach will be closed to public access until March.

Kerriann and Corey Kreuz 7 Doe Run Drive Notice of Intent

Joe Teixeira recused himself from the matter. Tom Hughes represented the applicant, who is proposing to add a garage to a single-family home. The garage, which would have living space above it, would be located in the buffer zone. A perennial stream runs under Doe Run Drive. Mr. Hughes said the garage would not be in the riverfront area.

A swimming pool had been installed without Commission approval, but this was not the fault of the applicant. The filing process in City Hall was being updated at the time and the Commission was not flagged as a part of the review process. A portion of the fence around the pool intruded into the wetlands. In addition, old wood and brush had at one time been disposed of in the 25-foot no-disturb zone. Fill would be removed to return the elevation to that of the wetland. Twenty square feet of vegetation would be planted. The area around the pool would be loamed and seeded. The wetlands around of the perimeter of the site would be cleaned. Mr.

Hughes agreed to add ten shrubs to the wetland outside the fence. He will provide a revised plan and list of plant materials.

8. Order of Conditions Kerriann and Corey Kreuz 7 Doe Run Drive

Carole Wagan moved to issue an Order of Conditions with the special conditions that: 1) simultaneous with the initiation of the construction of the house, the applicant shall replicate at least 20 square feet of bordering vegetated wetland, as shown on the approved plan; 2) the replication area and additional buffer zone planting area shall be monitored for at least two growing seasons for the survival of at least 75% of the plantings and 3) prior to the issuance of the Order of Conditions, the applicant shall submit a planting plan showing a details of the replication area and the additional planting area in the buffer zone that is to be planted with native species. Bill Mullen seconded the motion. The motion was approved by a 4-0 vote (Dan Warchol, yes; Steve Moore, yes; Charlie Alovisetti, yes; Bill Mullen, yes).
