The letter thanks Andy Willemsem, Director of the River Valley Charter School, for the RVCS' participation in planting the 4 trees on the center strip on Perry Way in front of the school in April. **ET** reported that Andy Willemsem is deeply interested in continuing RVCS participation in tree planting in Newburyport and suggested that the **TC** appoint a liaison to work with him.
