Water Treatment Plant Project

Paul Colby presented the Water Treatment Plant Project update.

He noted the following:

- Second train should be finished mid-March
- Painting is approximately 80% completed
- Electrical pulling out old wires and rewiring into new
- Backwash drain changed to 24-inch line and backwashing working better
- Old pump station demoed
- Gas service off at valve house
- New Scada control instrumentation panel in filter area

- Concerns with Plum Island continue
- Working on issues with Newbury concerning buildable and non-buildable lots
