3. Approval of Minutes

4. Water Operations Agenda

Dan Lynch presented the following:

- 1. Water Division work on the Culvert Project will be completed this week good experience but stressful
- 2. Rules & Regulations work in process with Tony Furnari, Larry Kelley, Dan Lynch and Kathe Talkington
- 3. Staffing levels 2 vacancies at Water Treatment Plant and 1 Distribution Interviews were held on November 12th. Waiting for candidates to respond to job offers.
- 4. Temporary bypass water line along Rte. 95 should be installed mid-December
- 5. Hydrant flushing complete
- 6. Repairing hydrants
- 7. Several repairs completed
- 8. Repairs delayed include:
