4. One Day License Informational Inquiry

Elena Bachrach, Executive Director of the Newburyport Art Association, inquired of the commission how to handle artist receptions at the galleries on Water Street. The commission reviewed the requirements for serving alcohol under one day license rules. She will notify the artists and get back to the commission with applications in the next two weeks.

5. Hearing Continuation Alteration of Premises Brown Sugar by the Sea

The hearing was continued from June 5, 2013. Mark Janos, attorney, Caroline Joliffe, owner of Brown Sugar by the Sea, and David Hall, property owner were present and spoke on behalf of the application. The commission members were able to do a walk through at the property prior to this meeting. David, Caroline and Mark are addressing concerns the commission had at the last meeting. The alcohol will be distributed by walking the stairs. No storage or distribution of alcohol will be on the deck. The elevator is no longer a part of the transportation system of alcohol. Only disabled customers and restaurant staff will have access to the elevator. They have addressed the mechanical and safety issues. Discussion followed with input from the commission. The commission requested plans for all three levels including heights.

A motion to conditionally approve the application was made by Donald Zabriskie and seconded by Joseph Devlin based on the following conditions:

- 1) There is a dedicated wait staff on the deck at all times. Runners would bring food and alcohol.
- 2) No alcohol will be stored on the deck.
- 3) All necessary City departments approve the deck.
- 4) The description on the petition to alter the premises should add "first floor partitions, second floor partitions, and staircase access control as per plans submitted on . .
- 5) Sliding partitions remain secure unless also an emergency egress.
- 6) Elevator not part of the licensed premises.
- 7) An addition to the lease amendment with a description of the additional space exclusive use.
