Information discussed about Event: They are having a private event on June 22, 2013 pending their pouring license going through. On June 29, 2013 they want to have a grand opening event from 12 noon to 7pm. It was suggested to them to amend their application to include the outdoor grassy area. The commission asked if they plan to use that area all of the time. Bill Fisher said no. The Commission said they should request a One Day License for any events taking place on the outdoor grassy area. They should not amend their application.

5. Hearing Alteration of Premises Brown Sugar by the Sea

The hearing was opened at 7:25pm. Mark Janos, attorney, Caroline Joliffe, owner of Brown Sugar by the Sea, and David Hall, property owner were present and spoke on behalf of the application. They are requesting an alteration to make the third floor deck contiguous to the first floor restaurant space to be able to serve alcohol. The seating is approximately 44. They are proposing building an additional staircase that would only be accessible on the first and third floors. In addition, they would have a hostess located in front of the elevator (and staircase), with an elevator key that would allow the patrons to only travel to the first and third floors. Currently the second floor is a business that operates during the day. They have two separate staircases for access to their floor. The elevator would be blocked on the second floor by a rolling partition that would be removed when the deck is closed. This would allow access to mechanical equipment stored on the second floor for use during the winter.

Questions from the board: How would you prevent someone from using the elevator to visit the second floor at 7:30am, this person would then have access to the third floor? The plan is to permanently prevent people from using the elevator to the 2nd floor. Has this plan been reviewed by the Fire Department? Yes, the stairs are all have sprinklers and have battery lights. Who would control the partitions? The Landlord would control the partitions, rolling them into place before the deck is opened, and out after the deck is closed in the fall. Did you look at other restaurants that have a similar setup? They looked at seven other examples, mostly in the Boston area. Other bars have not had any incidences arising from the decks. Did any share access? No. Commissions concern is making sure alcohol stays in the licensed premises and access to the premises is controlled. Commission asked the timeframe? As soon as possible. Anticipate construction to be 1 month.

One person spoke in favor of the applicant. Mark Wahlgren of 1 Spofford Street. Noone spoke against.

Brad Duffin made a motion to Table until commissioners could have a site visit, seconded by Richard Sharp.
